The 2022 Regular Legislative Session

The Tenth week of the 2022 Regular Legislative Session is complete. The deadline for original floor action on general bills and constitutional amendments originating in other house has passed. The deadline for original floor action on appropriations and revenue bills originating in other house is Tuesday, March 15.

Cash-in-lieu Legislation Enroute to the Governor's Desk (House Bill 843)

On Wednesday, March 9th, the House Chamber concurred with the changes that the Senate Chamber made to <u>House Bill 843</u> by a vote of <u>119 to 3</u>. With this action being taken, this measure will not go to conference but instead be routed to the Governor's desk. As a reminder, last year MAS worked to get a Medicare-in-Lieu bill passed into law that gave counties the opportunity to offer their Medicare eligible employees an opportunity to transition to Medicare and away from the county's health benefits plan. Unfortunately, we found out that the federal government (Medicare regulations) deemed it illegal to treat one group different from another group. House Bill 843 allows for a "Cash-in-Lieu" instead of Medicare in-lieu and this methodology will allow everyone to participate in Cash-in Lieu, without federal regulations creating any type of prohibitions.

Rural Fire Truck Acquisition Program Survives Deadline and Passes Senate Chamber (House Bill 842)

On Wednesday, March 9th, the Senate Chamber passed out <u>House Bill 842</u> by a vote of <u>52 to 0</u>. House Bill 842 authorizes **two** additional rounds for counties regarding the Rural Fire Truck Acquisition Assistance Program. **NOTE:** This measure will now head to the House Chamber for concurrence or nonconcurrence.

Purchasing Threshold Measure Survives Deadline and Passes House Chamber (Senate Bill 2371)

On Wednesday, March 9th, the House Chamber passed out <u>Senate Bill 2371</u> by a vote of <u>110 to 9</u>. Senate Bill 2371 increases from 50k to 75k for purchases from the lowest and best bidder without publishing or posting advertisement for bids, provided that at least two competitive bids have been obtained. **NOTE:** This measure now heads back to the Senate Chamber for concurrence or nonconcurrence.

State Revenue Collection Continues to Exceed Expectation

On Monday, March 7th, the Mississippi Legislative Budget Office (LBO) released their Fiscal Year 2022 Revenue Collections Report for the month of February. The report disclosed that the total revenue collections for the month of February FY 2022 is **\$101,362,084 or 31.76%** above estimated projections. Regarding Year-to-Date (YTD), revenue collections through February 2022 are \$768,408,412 or 21.46% above projected SINE DIE estimates.
