The 2022 Regular Legislative Session

The Fourteenth week of the 2022 Regular Legislative Session is complete. On Tuesday, April 5th, both the House and the Senate Chamber adjourned SINE DIE. The 2022 Regular Legislative Session has officially come to a close.

MAS 2022 Legislative Proposals Receives Favorable Consideration for the Majority of MAS Proposals

MAS 2022 Regular Legislative Proposals are as Follows:

- <u>Senate Bill 3024</u> Full funding of the homestead exemption reimbursement at \$90,600,000.00
- · <u>Senate Bill 2719</u> County supervisors salary realignment/increase
- House Bill 451 Rural fire truck funding
- House Bill 451 Creation of a "State" funded First Responders Health and Safety Act measure.

Legislature Passes Omnibus Appropriation Measure (House Bill 1353)

<u>House Bill 1353</u> is an appropriation that consists of "numerous" specific earmarks for various local road and bridge projects across the state. Please review this legislation to see if your county has received one of the line item earmarks.

Numerous American Rescue Plan Act Legislation (ARPA)

Local Gov't Water Infrastructure

Senate Bill 2822: This measure establishes the MS Municipal/County Water Infrastructure Grant Program. NOTE: The funding that will fund this program is located in Senate Bill 3056. The amount funding this program is \$450,000,000.00

Rural Water Associations Grant Program

House Bill 1421: This measure establishes the ARPA Rural Water Associations Infrastructure Grant Program to assist rural water associations in the construction of eligible drinking water infrastructure projects. NOTE: The funding that will fund this program is located in House Bill 1538. The amount funding this program is \$300,000,000.00.

Tourism Recovery

<u>**House Bill 453</u>**: This measure establishes a process for "Destination Marketing Organizations to access ARPA funds to help promote tourism in the various Mississippi counties and municipalities. The funding for this measure is located in Section 2 of this act, and the funding is around \$30 million.</u>

Broadband Deployment

House Bill 1029: This measure establishes the Broadband Expansion and Accessibility of Mississippi (BEAM) Act. Funding will come from state legislature support and federal grants.
