Weekly Legislative Update 2018 Regular Legislative Session March 9, 2018

MS HOUSE AMENDS THE B.R.I.D.G.E. ACT SENATE BILL 3046

On Wednesday March 7, the House Ways and Means Committee took action on Senate Bill 3046 with a "Strike All" amendment. The "Strike All" amendment made a number of changes, but as it pertains to counties statewide, the House reinstated its original language (HB-722) with a slight modification. The reinstated language consists of diverting 35% of the Use Tax and giving 15% for Counties and 15% for Municipalities. Now, instead of the other 5% going to MDA, it will now go towards the Local Systems Bridge Program. It is anticipated that this would generate between \$17 million to \$20 million a year. This will be in addition to the 15% Use Tax diversion. The 15% Use Tax diversion is expected to generate \$46 million annually. Both the 15% and the 5% will be residual revenue to Mississippi counties that would not need the approval of the Mississippi Legislature.

NOTE: The House Chamber has passed Senate Bill 3046 with the "Strike All" language. SB-3046 will now head to the Senate Chamber for Concurrence or Nonconcurrence.

AXLE WEIGHT TOLERANCE MEASURE PASSES HOUSE

On Tuesday March 6, 2018, The Mississippi House of Representatives passed Senate Bill 2418 by a vote of 76 to 34. This vote margin makes a clear statement that the leadership is highly in favor of passing an axle tolerance increase this year. MAS will continue to work against this measure and educate on the possible negative impact During MAS Regional Capitol Visits, this can have back at the county level from a public safety and cost standpoint.

NOTE: This measure will now head to the Senate Chamber for Concurrence or Nonconcurrence.

MEDICAID REAUTHORIZATION SENATE BILL 2836

Senate Bill 2836 is the legislative vehicle to reauthorize the Division of Medicaid. With the introduction of this bill, MAS has worked with the leadership to have language included that would allow Medicaid to help cover inmate hospital costs. The Senate Chamber supports this effort, but the House Chamber removed this language. Now, Senate Bill 2836 will head to conference for further conferencing.

STATE REVENUE COLLECTIONS UPDATE

On Monday March 5, 2018, the MS Legislative Budget Office released information regarding state revenue collections. The total revenue collections for the month of February FY 2018 are \$11,309,741 or 3.65% above the sine die revenue estimate. Fiscal Year-To-Date revenue collections through February are \$34,441,369 or 1.05% above the sine die estimate.
