# SENATE PASSES MAJOR INFRASTRUCTURE LEGISLATION THE BRIDGE ACT SENATE BILL 3046

On Tuesday February 20<sup>th</sup>, the Mississippi Senate passed their version of a major infrastructure package entitled the "Bridge Act." This comprehensive plan is designed to provide revenue for infrastructure needs across the state without raising taxes. The plan would be funded through diverting funds from existing revenue streams, in addition to issuing bonds for city, county, and state needs over a five-year period. This plan also includes \$60 million for the Local Systems Bridge Program. This is a \$1billion plan that is broken down into various sections. <u>Senate Bill 3046</u> has passed the Senate chamber by a vote of 36 to 14.

# **DEBT SETOFF LEGISLATION: HOUSE BILL 1029**

The Mississippi Association of Supervisors (MAS) has often discussed finding more effective ways to collect various debts owed to county government. <u>House Bill 1029</u> would give authorization to county and municipal government to collect debts by a setoff against a debtor's income tax refund. This bill has passed House chamber and now resides in the Senate Finance Committee.

# **CALL-TO-ACTION** FLEXIBILITY WITH REVERSE AUCTION IN DANGER OF DYING House Bill 1131

Changes were made to <u>House Bill 1131</u> that would allow a governing authority to determine that if reverse auction is "not" in the best interest of the governing authority they may explain in their minutes why they did not utilize reverse auction instead of having to request an exemption from the Public Procurement Review Board (PPRB).

For those counties that believe reverse auction is not in the best interest of their county, contact your local Senate delegation and ask that they support House Bill 1131.

NOTE: <u>House Bill 1131</u> now resides in the Senate Accountability, Efficiency, and Transparency Committee. If House Bill 1131 is not taken up and passed out of committee by <u>Tuesday February 27<sup>th</sup></u>, counties will be have to continue with the current reverse auction law with "NO" flexibility.
