## **CAMPAIGN FINANCE HEADS TO GOVERNOR**

On Wednesday March 22<sup>nd</sup>, the Mississippi Legislature passed a campaign finance reform measure (*SB-2689*) that would restrict the spending of campaign money on personal expenses by public officials. <u>Senate Bill 2689</u> was a compromise between the House and the Senate proposals from the last two sessions. This law defines personal use as any other expenditures not related to gaining, holding or performing functions of public office. In addition, it would also require credit card purchases to be itemized and not reported as a lump-sum payment. This measure is expected to take effect January 1, 2018, and any money collected by public officials prior to January 1<sup>st</sup> is exempt.

**NOTE:** The **Ethics Commission** will charge those in violation of the personal use rules with a misdemeanor, punishable by a fine up to <u>\$1,000</u> and an assessment equal to misappropriated funds.

## **RURAL FIRE TRUCK PROGRAM ACQUISITION**

The Rural Fire Truck Acquisition Program is normally listed in the Department of Insurance Appropriation. This year, that appropriation bill is House Bill 1498 and HB-1498 is headed to conference. If it is not appropriated, then there is a chance it could be bonded. Currently, this program is not in its normal appropriation nor in a bond measure.

# HOMESTEAD EXEMPTION REIMBURSEMENT CUT! (CALLS NEEDED)

**Senate Bill 2973** contains the homestead exemption reimbursement in **Section 6** of this bill. This bill is currently funding the homestead exemption reimbursement at **\$82,038,206.00**. This is a **\$2,416,435.00** cut from last year's funding level. **\$87.5** million is needed for "FULL" reimbursement.

## **MAS PROPOSAL ITEM HEADS TO CONFERENCE**

<u>Senate Bill 2836</u>: This bill raises the purchasing threshold from \$1,000 to \$1,500 for purchases that would "<u>NOT</u>" require a purchase requisition form.
